## **PLAYER REGISTRATION**

**The Hellenic League has the following system by which players may be REGISTERED by MEMBER CLUBS.**

1. Formatted Electronic (WORD) Template document forwarded by e-mail from the League Office to allow Club Officer's to readily print sufficient quantities on an as required basis, or downloaded from the HELLENIC LEAGUE WEB SITE.
2. ALL REGISTRATIONS WILL BE SUBMITTED by on-line Registration Form, however, clubs must still ensure the original Registration Form is fully completed and is used as a source document for submission via the League Web Site facility. Details can be found below:

1. A screen will appear advising restricted area and requesting user name and password. Complete with the user name and password previously provided by the league office to enter the area.
2. In the page now on view select your club from the menu .
3. Complete registration as detailed and submit.
4. If you have not completed the "required" information the system will default to a screen and tell you what information is missing. If that is the case then return to the previous page and add information, then submit again.
5. If the information has been submitted correctly the screen will show the information submitted, a copy of this will be sent to the Registration Officer and to the registered club email address ([yourclub@hellenicleague.co.uk](mailto:yourclub@hellenicleague.co.uk)). The screen will also give you the option to return and register further players or to return to the main site.

## **PLAYER PARENTAL AGREEMENT FORM**
